INFORMATION CLAUSE

Pursuant to Article 13 of Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (the General Data Protection Regulation) (Journal of Laws EU L 2016 No. 119/1), hereinafter referred to as the Regulation, the Publisher hereby informs that:

- 1. The Administrator of the personal data of the Author(s) is the University of Rzeszów, with its main seat at Rzeszów 35-959, al. Rejtana 16C, represented by the Rector,
- 2. The Data Protection Officer at the University of Rzeszów is Krystian Antochów, e-mail: iod@ur.edu.pl,
- 3. The personal data of the Author(s) will be processed in order to:
- a) perform the provisions of this agreement under Article 6 section 1 letter b¹ of the Regulation,
- b) fulfil the Publisher's legal obligation arising from the provisions of the act of 26 July 1991 on income tax from natural persons (Journal of Laws of 2018, item 200 with further amendments), act of 13 October 1998 on the social insurance system (Journal of Laws of 2017, item 1778 with further amendments) and secondary legislation related to the above mentioned acts, as well as other applicable legal provisions in force based on Article 6 section 1 letter c^2 of the Regulation,
- 4. Provision of personal data is **voluntary**, however, necessary to enter into this agreement. The consequence of failure to provide the data is the lack of possibility of forming this agreement.
- 5. The recipients of the personal data of the Author(s) will be proper tax authorities, Social Insurance Institution, as well as other recipients in cases resulting from the applicable laws. The recipient of the data can also be an entity commissioned by the Publisher (the Data Administrator), e.g. an entity providing IT services in the scope of removing technical problems and servicing IT systems.
- 6. The personal data of the Author(s) shall not be transferred to any recipients in any third country or to any international organisation.
- 7. The personal data of the Author(s) will be processed for the duration of a term necessary to perform this agreement. After this term the data will be stored for the purpose, for the

duration and in the scope required by applicable laws or to secure possible claims. After the term of storage, the data will be irrevocably deleted or irrevocably atomised.

- 8. The Author(s) has/have the right to access the content of their personal data, to rectify it, to restrict its processing or to erase it, subject to the provisions of the law.
- 9. The Author(s) has/have the right to transfer their data to another entity upon submitting an application for data transfer to the Publisher.
- 10. The Author(s) has/have the right to lodge a complaint with an appropriate supervisory authority if they believe that the procedure of processing their data violates the provisions of Regulation.
- 11. The personal data of the Author(s) will not be subject to automated individual decision-making, including profiling.
- 12. The personal of the Author(s) data will be released on the Publisher's website of the publication.
